Line 1A City of Owensboro

Line 2A City of Owensboro

Column I - Enter the total **net profit or loss**, as originally reported or adjusted, resulting from: real estate rental if the **Gross Receipts** from such rental is \$5,000 or less for periods ending on or after 12/31/06, or for the rental of less than 10 single habitable residential units if period ending is prior to 12/31/06; the sale of farm products by a farmer in the city limits, as defined by regulation; and amounts earned prior to attaining age 16. If the amount is a **net profit, enter as a negative number**. If the amount is a **net loss, enter as a positive number**. **Attach Schedule showing exempt amounts.**

Column III - Enter the corrected total **net profit or loss** resulting from: real estate rental if the **Gross Receipts** from such rental is \$5,000 or less for periods ending on or after 12/31/06, or for the rental of less than 10 single habitable units if period ending is prior to 12/31/06; the sale of farm products by a farmer in the city limits, as defined by regulation; and amounts earned prior to attaining age 16. Line 3A City of Owensboro

Line 3B Daviess County

Column I - Enter the **Adjusted Net Profit** as originally reported or adjusted. Line 1B plus Line 2B.

Column III - Enter the **Adjusted Net Profit** as amended. Line 1B plus Line 2B

Column II - Enter the net increase or decrease to **Adjusted Net Profit**.

Line 4A City of Owensboro

Column I - Enter the **Business Apportionment Percentage** as originally reported or adjusted.

Column III - Enter the **Business Apportionment Percentage** as amended.

Column II - Enter the net increase or decrease to the **Business Apportionment Percentage**.

Line 4B Daviess County

Column I - Enter the **Business Apportionment Percentage** as originally reported or adjusted.

Column II - Enter the net increase or decrease of **Taxable Net Profit**.

Line 6A City of Owensboro

Column I - Enter 1.33% of Line 5A as originally reported or adjusted.

Column III - Enter 1.33% of Line 5A as amended.

Column II - Enter the net increase or decrease of **License Fee Due**.

Line 6B Daviess County

Line 7A City of Owensboro

Column I – Enter penalty as originally reported. Any licensee who fails to file and/or pay the license fee by the due date shall pay penalty at the rate of 5% per calendar month, not to exceed 25% of the total license fee due, however, the penalty will always be a minimum of \$25. Multiply applicable percentage by Line 6A.

Column III – Enter penalty due on the amended license fee due. Any licensee who fails to file and/or pay the license fee by the due date shall pay penalty at the rate of 5% per calendar month, not to exceed 25% of the total license fee due, however, the penalty will always be a minimum of \$25. Multiply applicable percentage by Line 6A.

Column II – Enter the net increase or decrease of penalty.

Line 7B Daviess County

Column I – Enter penalty as originally reported. Any licensee who fails to file and/or pay the license fee by the due date shall pay penalty at the rate of 5% per calendar month, not to exceed 25% of the total license fee due, however, the penalty will always be a minimum of \$25. Multiply applicable percentage by Line 6B.

Column III – Enter penalty due on the amended license fee due. Any licensee who fails to file and/or pay the license fee by the due date shall pay penalty at the rate of 5% per calendar month, not to exceed 25% of the total license fee due, however, the penalty will always be a minimum of \$25. Multiply applicable percentage by Line 6B.

Column II – Enter the net increase or decrease of penalty.

Line 8A City of Owensboro

Column I – Enter interest as originally reported. Any licensee who fails to pay the license fee by the due date shall pay interest at the rate of 1% per calendar month, or fraction thereof, of any license fee due. Multiply Line 6A by applicable percentage.

Column III – Enter interest due on the amended license fee due. Any licensee who fails to pay the license fee by the due date shall pay interest at the rate of 1% per calendar month, or fraction thereof, of any license fee due. Multiply Line 6A by applicable percentage.

Column II – Enter the net increase or decrease of interest.

Line 8B Daviess County

Column I – Enter interest as originally reported. Any licensee who fails to pay the license fee by the due date shall pay interest at the rate of 1% per calendar month, or fraction thereof, of any license fee due. Multiply Line 6B by applicable percentage.

Column III – Enter interest due on the amended license fee due. Any licensee who fails to pay the license fee by the due date shall pay interest at the rate of 1% per calendar month, or fraction thereof, of any license fee due. Multiply Line 6B by applicable percentage.

Line 9A City of Owensboro

Line 9B Daviess County

Column I – Enter total amount due as originally reported. Add Lines 6B, 7B and 8B.

Column II – Enter the net increase or decrease of the total amount due.

Line 10A City of Owensboro - Enter the amount of license fee, interest and penalty paid with original return.

Line 10B Daviess County - Enter the amount of license fee, interest and penalty paid with original return.

Line 11A City of Owensboro - Enter any existing payments or credits not claimed on the original return.

Line 11B Daviess County - Enter any existing payments or credits not claimed on the original return.

Line 12A City of Owensboro - Enter total payments and credits. Line 10A plus Line 11A.

Line 12B Daviess County - Enter total payments and credits. Line 10B plus Line 11B.

Line 13A City of Owensboro – Enter refund or credit, if any, shown on original return.

Line 13B Daviess County - Enter refund or credit, if any, shown on original return.

Line 14A City of Owensboro – Enter adjusted credits. Line 12A minus Line 13A.

Line 14B Daviess County – Enter adjusted credits. Line 12B minus Line 13B.

Line 15A City of Owensboro - If Line 9A of Column III is more than Line 14A, enter the amount due. **Any overpayment of license fee to the City of Owensboro, including payments made with an extension request, will not be allowed to offset any underpayment of license fee to Daviess County. Any overpayment of license fee to Daviess County, including payments made with an extension request, will not be allowed to offset any underpayment of license fee to the City Of Owensboro.**

Line 15B Daviess County - If Line 9B of Column III is more than Line 14B, enter the amount due. **Any overpayment of license fee to the City of Owensboro, including payments made with an extension request, will not be allowed to offset any underpayment of license fee to Daviess County.
